# WLIF-HD2, WWIN-FM, WOLB-AM "First Ladies Tea" Contest 2018 OFFICIAL CONTEST RULES

NO PURCHASE NECESSARY TO ENTER OR WIN.

#### **CONTEST DESCRIPTION:**

The "First Ladies Tea" Contest ("Contest") will begin on August 6, 2018 and end on September 3, 2018 ("Contest Period"). ## **ENTRANCE GUIDELINES**

The Competition is open to listeners of WLIF-HD2, WWIN-FM, and WOLB-AM ("Station") who are twenty-one (21) years of age and older and are legal residents of the U.S. residing within the Baltimore, MD – Washington, DC metropolitan area.

- 2. Upon entering the Contest website, participants are to follow the on-screen instructions, including entering their name, date of birth, address, phone number, email address, submit their video entry, and any optional or additional contact information including the name of the pastor's wife that they are nominating and why that person deserves to win, as requested, to register for a chance to win.
- 3. By nominating a pastor's wife and entering this Contest, each participant represents and warrants to be bound the Official Contest rules, and that they are authorized to and have the rights to submit the content in the entry.
- 4. Entry submission will begin on Monday, August 6, 2018 at 12am EST. All Internet entries must be received by 11:59pm EST on Monday, September 3, 2018, or they will be void.
- 5. Entries will be posted online for public voting. The Voting Period will begin on Wednesday, September 5, 2018 at 10am and end on Sunday, September 14, 2018 at 11:59pm. At the end of the Voting Period, the top ten entries receiving the most votes will be declared the Grand Prize Winners.
- 6. One (1) vote per person, per day during the Voting Period. Any attempt by an entrant and/or his/her family/friends to vote more than the number of times authorized by using multiple names or email address and/or any other fraudulent mechanism as determined by the Station in its sole discretion, shall give the Station the right to disqualify the entrant in its reasonable discretion.

## **ELIGIBILITY RESTRICTIONS:**

- 1. The Contest is open only to legal residents of the United States who live in the Baltimore, MD Washington DC metropolitan area and are twenty-one (21) years of age or older at the time of Contest registration.
- 2. Employees of the Station, Radio One, Inc. (the "Company"), their respective subsidiaries, affiliates, parent companies, general sponsors, advertisers, competitors, promotional partners, other radio stations in the Baltimore, MD / Washington, DC metropolitan area, and members of the immediate families or those living in the same households (whether related or not) of any of the above are NOT eligible to participate or win in this Sweepstakes. - 2. Entries will be posted online for public voting. The voting period will begin on Monday, September 5, 2018 at 10am and end on Sunday, September 14, 2018 at 11:59pm. At the end of the Voting Period, the top ten entries receiving the most votes will be declared the Grand Prize Winners.
- 3. The winners will be notified by phone and / or email and provided with instructions for claiming their prize.
